INTRODUCTION



On behalf of the Conference Organising Committee, I am delighted to formally invite you to attend the 33rd annual ANZSLA Conference in Sydney, one of the world's most iconic destinations.

Sydney is a stunning and vibrant city built around one of the most beautiful bays in the world with sparkling beaches and easy access to the heart of the city. The oldest and largest city in Australia, Aboriginal people have a long connection with Sydney, dating back at least 50,000 years before the first settlers arrived in 1788.

Sydney has a rich sporting history. It proudly announced itself on the world stage by hosting one of the most memorable Olympic Games in 2000 – described by the then-IOC President as 'the best Games ever'. It is home to a number of world-class sports stadiums, including the SCG, the Sydney Football Stadium and Stadium Australia at Sydney Olympic Park which last year hosted the final of the 2023 FIFA Women's World Cup. Sydney also has a rich legal history. It is home to the Supreme Court of NSW, one of the state's most respected civic institutions, which recently celebrated its bicentenary - 200 years of administering the law and resolving disputes in NSW, including presiding over a number of leading sports law cases.

This year's conference will be held at the new Crown Sydney hotel in Barangaroo on the north-western edge of the CBD. Barangaroo is named after <u>a powerful</u> <u>Cammeraygal woman</u> who lived in the area at the time of early colonial settlement. It is now Sydney's newest and liveliest waterside precinct – a thriving hub which boasts beautiful parkland, excellent bars and restaurants and innovative architecture.

The Organising Committee has worked hard to develop an engaging and enlightening programme for this year's conference. As a result, you will hear from a distinguished lineup of speakers and panellists on some of the most topical and contested sports law issues, including the latest developments in anti-doping, major event planning, governance, media rights, regulation of agents, player injury, competition law, corporate social responsibility and human rights. For the first time, some sessions will be run concurrently to cater for ANZSLA's diverse membership and to increase the amount of high quality content available to delegates. In another first, one of the sessions will be a mock arbitration using National Sports Tribunal procedures.

The programme includes some outstanding speakers. The Hayden Opie Oration will be delivered by The Hon. Annabelle Bennett AC SC, a former Federal Court judge who has presided over some of the most important sports arbitrations. The other keynote addresses will be from Jonathan Taylor KC (one of the world's leading sports lawyers), James Johnson (former sports lawyer and current CEO of Football Australia) and Kat Craig (founder and CEO of Athlead, a not-for-profit consultancy specialising in sport and human rights). We are also delighted to have leading sports journalist, Tracey Holmes, as our conference MC.

Delegates will be encouraged to participate actively in all sessions, to engage in robust and respectful debate, to share ideas and experiences and to ask questions. Outside of the programme, there will be plenty of opportunity for catching up with your sports law colleagues and friends, and for making new ones. All of our social events will be on the harbour's edge with spectacular water views. Our welcome reception will be hosted in the Yallamundi rooms of the iconic Sydney Opera House, and the conference dinner will be held at Meers Hall, a beautiful and contemporary event space within the Art Gallery of NSW. The conference will be wrapped up with closing drinks at The Sporting Globe.

Paul Trisley was a highly regarded sports lawyer and one of ANZSLA's most dedicated members for many years. Paul died in 2001 and this award acknowledges his tremendous contribution to ANZSLA and the area of sports law generally.
